SUBJECT:	EXERCISE AND RECREATION

PROCEDURE

All recreational yard qualified inmates will have an opportunity to utilize the yard for at least two 1.5-hour blocks weekly (Monday – Friday). [REDACTED]

I. LOGGING ACTIVITIES

- A. Entries for "REC YARD STARTED" and "REC YARD ENDED" will be entered into JIMS as outlined in Detentions P&P T.11. The Housing Control Deputy will specify which tier or quad is utilizing the recreational yard.
- B. Events such as inclement weather, refusals, or inmates voluntarily ending the block early will be logged in JIMS accordingly.
 - 1. An entry will be made in JIMS by selecting "REC YARD UNAVAILABLE" from the drop-down of the Area Activity. The "Description" must specify the reason recreation time was not available.
 - 2. If the inmates are removed from the recreational yard before the end of the scheduled block, the housing control deputy will notate the reason (i.e. inmate request, medication, facility lockdown) in the "Notes" area of the "REC YARD ENDED" JIMS activity log.
 - 3. If a module refuses a recreational yard opportunity, The Housing Control Deputy will specify which tier or quad refused the recreational yard.

Deputies should utilize this opportunity as a "Make Up" slot and offer recreational yard to another module which has not yet met the minimum entitlement of three hours per week.
