SUBJECT:	PROPERTY ISSUED TO INCARCERATED PERSONS

PROCEDURE

- I. When an incarcerated person is booked and transferred to housing, they will receive the following issued items:

- One (1) blue or green shirt
- One (1) pair of blue or green pants
- One (1) sweatshirt
- Two (2) bras
- Four (4) pairs of underwear
- Four (4) pairs of socks
- One (1) pair of shower shoes
- Two (2) blankets/ three (3) blankets seasonally
- Two (2) towels
- One (1) nightgown
- One (1) hygiene kit

- II. Incarcerated person workers will be issued the following:

- Two (2) tan shirts
- Two (2) tan pants
- One (1) pair of tan shorts (for recreation yard/room & in house cleaning)
- One (1) white t-shirt
- One (1) long sleeve white t-shirt (landscaping & coffee cart only)
- Two (2) bras
- Three (3) pairs of underwear
- Three (3) pairs of socks
- One (1) sweatshirt
- One (1) nightgown
- Two (2) blankets/ three (3) blankets seasonally
- One (1) towel
- One (1) hand towel
- One (1) pillow case
- One (1) pair of shower shoes
- One (1) pair of issued tennis shoes only to be worn at the facility
- One (1) pair of leather work boots for landscaping workers
- One (1) pair of rubber kitchen boots (kitchen workers only)

III. Incentive Based Housing (IBH) will be issued the following:

- Two (2) blue shirts
- Two (2) blue pants
- One (1) pair of blue shorts (for recreation yard/room & in house cleaning)
- One (1) white t-shirt
- Three (3) bras
- Five (5) pairs of underwear
- Five (5) pairs of socks
- One (1) sweatshirt
- One (1) nightgown
- Two (2) blankets/ three (3) blankets seasonally
- Three (3) towels
- One (1) hand towel
- One (1) pillow case
- One (1) pair of shower shoes
- One (1) pair of issued tennis shoes only to be worn at the facility

IV. Incarcerated persons confirmed by health staff to be pregnant or recovering from childbirth will be issued incarcerated person clothing (in compliance with their appropriate classification and housing assignment) printed with red lettering rather than white lettering.

V. Incarcerated persons placed into Enhanced Observation Housing (EOH) will be given:

- One (1) green safety garment
- Two (2) safety blankets
- One (1) pair of shower shoes

VI. Incarcerated persons housed in Administrative Separation and the Psychiatric Stabilization Unit:

As part of the incarcerated person safety program, these incarcerated persons will be issued the same clothing items as listed in section (I), but instead of cotton blankets they will be issued 2 safety blankets.
