SUBJECT:	Personal Protective Equipment (PPE)

PROCEDURE

1) In the event an opioid overdose consists of known Fentanyl or the threat of Fentanyl may exist with an unknown narcotic, additional Personal Protective Equipment (PPE) must be used. The following is a list of PPE available at San Diego Central Jail (SDCJ) rated to protect from Fentanyl:

1. P-100 Disposable Respirators
2. Clear Lens Protective Non-Vented Goggles
3. Tyvek Hooded Disposable Coveralls
4. Disposable Calf Length Boot Covers
5. Disposable Arm Sleeves
6. Nitrile Disposable Gloves

A. Prior to utilizing a P-100 rated respirator at SDCJ, the State of California Division of Occupational Safety and Health (Cal/OSHA) mandates that all users shall be "fit-tested" prior to use. A fit-test and any respirator questions will be done by contacting the facility training coordinator.

1. The P-100 respirator will only be used when the threat of Fentanyl is present. For any other respirator need, N-95 disposable respirators are to be used (e.g. airborne medical contaminant prevention, OC/aerosol protection, etc.).

B. Disposal of potential Fentanyl contaminated PPE, whether it be a full suit or just an exposed respirator, will be placed into a Burn-up Bin Biohazard Waste Box. Do not place contaminated PPE into regular trash bag or red medical biohazard bags. Burn-up bins will be located in the Govt. Code 6255(a) and will need to be brought to the affected areas.

1. Burn-up bins contain lids with round openings for the placement of contaminated PPE.
2. Proper PPE will be utilized if picking materials or other items from the floor to be placed into the bin.
3. When disposal is complete, close opening in lid, utilize transport handles, and return bin to evidence room to be disposed of by the visit deputy. Do not throw bin into the trash or place in any other area.
4. Notify the visit deputy and training coordinator when a Burn-Up Bin is used.

2) **PPE LOCATIONS**

Emergency Rapid Response kits will be located throughout the facility. These kits are only to be utilized when a potential exposure to Fentanyl exists, but an immediate response is needed.

Deputies may use any or all contents of the kits in order to protect themselves when responding. The kits contain the following items:

- 6 - P-100 Disposable Respirators
- 6 - Clear Lens Protective Goggles
- 6 - Tyvek 4XL Hooded Disposable Coveralls
- 6 - Disposable Pairs of Calf Length Boot Covers
- 6 - Disposable Pairs of Arm Sleeves
- 1 - Box of Large Nitrile Disposable Gloves

- A. The kits will be located at the following locations as well as personnel responsible for checking the kits:

- B. Each Rapid Response kit will be checked at the start of every shift. Each kit will be sealed with a red, numbered, breakable plastic tab. If the tab is unbroken and the kit is accounted for, add "kit accounted for – (plastic tab number here)" to the naloxone entry log. By logging the plastic tab number, we are ensuring no tampering of the kit contents has occurred. If the plastic tab is compromised in anyway, notify the facility training coordinator or any other administrative deputy.
- C. In addition to the PPE kits, a package of (5) P-100 masks will be kept in the control areas on Floors 3-8. It will be the responsibility of the Control Deputy to log the masks in the JIMS Area Checklist under "Equipment Summary" ex. (All (5) P-100 masks accounted for). Should the packaging be opened and/or masks removed, contact SDCJ Administration.
