



Enhancements

Enhancements are statute codes utilized to indicate that an individual has prior convictions or other factors which may contribute to the length of a sentence or increase bail. Enhancements must be booked, and the bail amount added to the total bail. Enhancements will NOT be entered when updating an incarcerated individual's record from a court document.

The booking and application of bail for enhancements is in addition to bail stacking procedures, as outlined in the San Diego Superior Court Bail Schedule. Whether or not the AO/ transporting officer indicates bail is to be stacked for the charges listed on the Booking Intake/Personal Property Inventory form (J-15), **bail stacking will always be applied to enhancements** (See **Setting Bail** or the **San Diego County Superior Court Bail Schedule** for bail stacking procedures).

When an Enhancement charge is entered in the JIMS, it will be clearly indicated with an "E" in the bail flag descriptor. Ensure that the enhancement bail is "stacked" with the highest bail amount of the charge(s) entered.

Leave the enhancement bail flag as E and in the note's sections type "STACK BAIL/ENHANCEMENT". You may also view these procedures in the Pre-Book Manual's [Field Arrest with Enhancement](#) section.

Per the [San Diego County Superior Court Bail Schedule](#), "sentencing enhancement provisions (see attached list), which require the imposition of bail in addition to the bail imposed pursuant to an underlying offense, are designated in the Bail Schedule with an "E" in the punishment column."

NOTE: Per the California Penal Code Handbook should be referenced for any charges/enhancements not currently listed in the San Diego Superior Court Bail Schedule.
