





# Interstate Compact Probation Violator

Pursuant to Penal Code 11177.1, an agreement can be made between states to allow a person on probation from another state to reside in California. The offender will be supervised by the Probation department.

The offender will be brought into custody with a J-15 & Interstate Compact Violator Hold.

**BOOKING**

When an Interstate Probationer is brought into Sheriff's custody, the DPT will use the following procedures:

- Type of arrest will be BFUG – Booked Fugitive
- Charge Code is 11177.1/1203.2(a)
- Billing Agency is PROB
- Bail: N – No Bail
- Court information will be left blank as these offenders agree to waive any right to extradition when they signed the application for Interstate Compact Transfer.
- A copy of the Interstate Compact Violator Hold shall be faxed to the Sheriff's Extraditions Unit.

The demanding state has 30 days from when the jail receives the warrant to extradite the offender. This is monitored by the Sheriff's Extradition's Unit. Once the unit has received confirmation from the

demanding state, they will fax over pickup instructions. Notice of the incarcerated individual's pickup information must be forwarded to Medical so they can produce the incarcerated individual's medical information.

**RELEASE**

When the Interstate Probationer is processed for release the DPT will use the following procedures:

- Release Disposition will be FUG – Fugitive
- Agency Released to: the demanding state
- Release Approval Report will be generated and filled out accordingly

If the demanding state does not extradite the offender and orders them to self-report to the state, the Sheriff's Extraditions Unit will notify IPD staff and fax over an add/drop charge form with reporting instructions. The release type will be 849B1 and the DPT will generate a [Certificate of Release SO-23 form](#) which will be provided to the incarcerated individual along with their reporting instructions upon release.

**PENAL CODE 1551/1551.1**

If IPD staff books a fugitive warrant booked pursuant to Penal Code 1551 or Penal Code 1551.1 and it is then discovered that the warrant is in fact an Interstate Compact case, they may be notified by the Sheriff's Extraditions Unit. If this occurs the processing DPT will close out Penal Code 1551 or Penal Code 1551.1 with the disposition of OTH and add the charge of Penal Code 11177.1/PC 1203.2(a) to correctly reflect the incarcerated individual's arrest.
