

Additional Arrests

If an incarcerated individual is in custody on more than one case or has HOLDS, each arrest/case must be entered as a subsequent ARREST. Additional arrests can occur during all phases of processing as the following examples indicate:

- An active, bookable warrant is found when completing the wants and warrant search during booking or a custody record review
- An additional Booking Intake/Personal Property Inventory (form J-15) and Probable Cause Declaration are received for a new field arrest for an incarcerated individual already in Sheriff's custody on other matters
- During court proceedings, the incarcerated individual can be heard on a case, they are not currently booked on and a court document is received remanding the incarcerated individual to custody on that case
- All booked cases have been closed out and the incarcerated individual has a HOLD(s)

NOTE: The Charge Review Navigator must be reviewed by staff at the facility where the additional arrest was processed to ensure accuracy of the information entered.

ADDITIONAL ARREST NOTIFICATION

Reference: Sheriff's Policy and Procedure section Q.25 Incarcerated Individual Additional Arrest Notification

California Penal Code section 850(c) requires an incarcerated individual to be advised of any additional charge(s) or hold(s) placed against them after the initial booking. Facility personnel shall, upon receipt of information as to the existence of any warrant of abstract, inform the incarcerated individual of this in writing.

The PC 850(c) Notification (form J-124) is used to notify incarcerated individuals in custody that a warrant or abstract was discovered after the initial booking process. This includes out of county, fugitive, military deserter, and federal warrants. This does NOT include parole violations or immigration detainers (See PC 850(c) Warrant Notification Section on p.6).

HOLD ARREST

Once all booked arrests are adjudicated and the incarcerated individual has one or more HOLDs arrest(s), an additional arrest is generated changing the status of the HOLD to BOOKED. The Hold arrest is closed out using the disposition RBHD - Rebook Hold.

NOTE: Remember to enter the disposition date and time.

The following is the order in which arrests shall be booked:

- 1. Local cases (field arrests, warrants and PC 3056 parole violators)
- 2. Out-of-County cases
- 3. State cases (i.e., CYA/DJJ, WI 3151 parole violators, PC 3056 prior to 10/01/11 etc.)
- 4. Federal cases
- 5. Fugitive cases

Example: An incarcerated individual is brought in on a field arrest, with two additional warrants; a warrant out of Orange County and a warrant out of the state of New Mexico. The field arrest is booked, and both the Orange County (out of county) warrant and the New Mexico (fugitive) warrant are placed as HOLDs. When the local case is adjudicated, an additional arrest is generated for the Out-of-County warrant and the Hold Arrest for that warrant is closed out with the disposition of RBHD – Rebook HOLD. The fugitive warrant will remain as a Hold arrest.

SENTENCED TO STATE PRISON

During the court update process, if a remanding court order is received and an
additional arrest is generated for an incarcerated individual sentenced to the California
Department of Corrections and Rehabilitation, it is necessary to verify whether the
incarcerated individual is scheduled for an upcoming prison run. A disposition of CDC –
California Depart Correction Transport on an arrest, indicates the incarcerated
individual is scheduled to be transported.

If so, the following must be completed:

- Inform the on-duty DPS to have the scheduled event deleted
- Change the CDC disposition to DOCP
