## **BOOKED ARREST TYPES**

Choosing the correct type of arrest is extremely important as this affects many functions. For more detailed information and examples of arrest types, refer to the Inmate Processing Division Pre-book Manual.

Booked arrest types are used to indicate an active arrest(s). All local charges/cases and/or warrants shall be entered as the primary arrest using the correct Booked arrest type. The following is a list and description of all currently used Booked Arrests:

**ARST - FIELD ARREST:** Used for pre-arraigned charges when a completed Booking Intake/Personal Property Inventory (form J-15) and Probable Cause Declaration (PCD) are received. Generally used for a person arrested in the act of committing a crime or as a result of committing a crime.

The inmate **must** be scheduled for arraignment within 48 hours after arrest per California Penal Code 825. Refer to the Court Destination Dates for Field Arrests and Limited Court Warrants Chart.

**BCMT** – **BOOKED COURT COMMIT:** Used when a court document is received ordering an inmate serve a sentence in Sheriff's custody. This SNT disposition automatically populates for all charges based on this arrest type. The sentence will be calculated (*See Sentence Calculation Section*). When processing an 1170(h) the arrest type of BCMT will also be used. Also, the disposition of SNT will be changed to 1170.

The court document may have a future hearing date. This date will need to be entered into the JIMS in the event the inmate is in custody at the time of the hearing.

**BCOU – BOOKED COURTESY:** Used for inmates brought into Sheriff's custody en route to another destination OR to serve a sentence from another county or state jurisdiction (*See Courtesy Housing/En Route Procedures Section*).

**BCPA – BOOKED COUNTY PAROLE:** Used for inmates previously granted county parole and returned to Sheriff's custody for violating the terms and to finish their remaining time (*See County Parole Section*).

**BCW – BOOKED COMMIT WARRANT:** Used for No Bail warrants that state the number of days the subject is committed to custody. The inmate **must** be scheduled for arraignment within 48 hours after arrest per California Penal Code 825. Refer to the Court Destination Dates for Field Arrests and Limited Court Warrants Chart.

The SNT disposition automatically populates for all charges based on this arrest type. A sentence calculation will NOT be completed until a court document is received after the court hearing. The case is NOT to be released per PC 825.

- **BCYA BOOKED CYA:** Used for inmates with a Department of Juvenile Justice (DJJ; formerly California Youth Authority-CYA) warrant/detainer and no other local charges/cases pending (*See Juveniles Section*).
- **BDET BOOKED DETAINER:** Used for US Marshall, Federal and/or California Department of Corrections and Rehabilitation (CDCR) detainers once all local charges/cases have been adjudicated. The inmate will appear on the appropriate reports based on this arrest type.
- **BDOC BOOKED DOC COMMIT:** Used when a court document is received sentencing an inmate to the California Department of Corrections and Rehabilitation (CDCR) or State Department of Mental Health (Patton, Metro, Atascadero, etc.). The inmate will appear on the appropriate reports based on this arrest type.
- **BFED BOOKED FEDERAL:** Used for federal prisoners being housed temporarily in Sheriff's custody to include US Marshall (USM) and Drug Enforcement Agency (DEA) arrests (See Federal Inmates Section).
- **BFUG BOOKED FUGITIVE WARRANT:** Used for warrants from another state when an inmate has no other local charges/cases pending (*see Fugitive section*). The inmate will appear on the appropriate reports based on this arrest type and will be tracked by Sheriff's Fugitive Unit.
- **BICE BOOKED IMMIGRATION:** Used for immigration and customs enforcement detainers when an inmate has no other local charges/cases pending. The inmate will appear on the notify list based on the type of arrest.
- **BJUV BOOKED JUVENILE COURT WARRANT:** Used for warrants issued out of the Juvenile Court division (*See Juveniles Section*). The inmate must be scheduled for court. Refer to the Court Destination Dates for Field Arrests and Limited Court Warrants Chart.
- **BMCW BOOKED MUNICIPAL COURT WARRANT:** Used for warrants issued out of the San Diego County Municipal Court Division. Arrest type is determined by the court indicated on the warrant and not the case number. The inmate must be scheduled for court per California Penal Code section 825. Refer to the Court Destination Dates for Field Arrests and Limited Court Warrants chart.
- **BMH BOOKED MENTAL HEALTH:** Used for court documents received with a mental health (MH) case number. The document controls all aspects as to the court, charges, bail and future court date.
- **BOC BOOKED OUT-OF-COUNTY WARRANT:** Used for warrants from another county within California. The inmate **must** be transported to the county of jurisdiction per California Penal Code 821. The inmate will appear on the appropriate reports based on this arrest type (*See Out of County Section*).

- **BPCS BOOKED POST RELEASE COMMUNITY SUPERVISION:** Used when an inmate is brought to Sheriff's custody to serve flash incarceration not to exceed 10 days per California Penal Code section 3453(a).
- **BPRV BOOKED POST RELEASE VIOLATION** (**PROBATION REVOCATION**): Used for inmates whose probation has been revoked and returned to Sheriff's custody per California Penal Code section 3455, pending a revocation hearing.
- **BRMD BOOKED REMAND:** Used for San Diego County Superior Court documents received with a future court date.
- **BSCW BOOKED SUPERIOR COURT WARRANT:** Used for warrants issued out of the San Diego County Superior Court Divisions, drug court (\$55,555/\$27,777/\$2,777), re-entry court (\$66,777), proposition 36 and PC 1210 warrants. Arrest type is determined by the court indicated on the warrant and not the case number. The inmate will appear on the appropriate reports based on this type of arrest and be scheduled for court by court personnel.
- **BSTP BOOKED STATE PAROLE:** Used when a warrant abstract from the Department of Corrections and Rehabilitation (CDCR) is received for inmates who have violated the terms of their parole per California Penal Code section 3056. The inmate will appear on the appropriate reports based on this arrest type (*See State Prison Commits Section*).
  - For violations received prior to October 1, 2011, inmates must have no other local charges/cases pending and will be transported back to a state CDCR facility.
  - Inmates with violations received after October 1, 2011 will remain in Sheriff's custody pending a Probable Cause Hearing. These violators can be returned to State Prison only at the direction of the California Board of Parole.
- **OBKD BOOKED OTHER:** Used for court book and release arrests, inmates booked in absentia, bail bond surrenders and military deserters (*See Court Book and Release*, *Booked in Absentia, Bail Bond Surrender and Military Deserters Sections*).
- **OSNT SENTENCED OTHER:** Used for work release, weekenders, to reports and/or when no other sentence/commit type of arrest applies (*Wee Weekender and To Report Sections*).
