

# Phase I Day V Exercises Answer Key

#### **KOPPEL**

- 1. How many arrests will inmate Koppel have? 2. The charge of 14601.2(a) VC no longer meets the Booking Acceptance Criteria.
- 2. Will the charge of 1203.2 PC be entered into JIMS? If or if not, please explain why. The charge of 1203.2 PC will **not** be entered into JIMS; it only identifies the type of probation inmate Koppel violated.
- 3. According to the Probation Violation form, inmate Koppel has two court case numbers: M007105 & CN280928. Will Koppel be booked on both of these cases in JIMS? Yes, each will be booked as a separate arrest type.
- 4. What will the arrest type be in JIMS for these cases? Field Arrest
- 5. Will additional PCD's be needed for these cases? No, the initial PCD will suffice. Ensure that the charge of 23154(A) VC is listed on the PCD.

## **TORSTROM**

- 1. What is the Arrest Type for inmate Torstrom? BCPA or Booked County Parole
- 2. According to the J-15, the Court Destination of: SD is circled. Will inmate Torstrom be scheduled for court? No
- 3. What is inmate Torstrom's case #? SCD212291PB
- 4. According to the warrant, what charge will be entered into JIMS? 459 PC
- 5. What notes need to be entered into JIMS? County Parole Violator; Contact Correctional Counselor's name & phone number.
- 6. Should this arrest be dispo'd out as a sentence? Yes, dispo out the arrest SNT.
