(F) Felony (M) Misdemeanor (I) Infraction

- SDPD (San Diego Police Department) makes an arrest on a (M) 647(f) PC and (M) 148(A)
 PC.
 - CITY, 647(f) PC IS ON THE B.A.C. AS #3; 148(A) PC ISN'T; ACCORDING TO THE B.A.C. #11-FIELD ARST CHARGES THAT DO NOT MEET THE BOOKING ACCEPTANCE CRITERIA BROUGHT IN BY SDPD/SDHP QUALIFY AS CITY INMATES.
- 2. ECPD (El Cajon Police Department) arrests on an El Cajon Municipal Court Warrant for (M) 243(E)(1) PC.
 - NO, ALL DOMESTIC VIOLENCE WARRANTS ARE ACCEPTED BY ALL LAW ENFORCEMENT AGENCIES (BAC #3-WARRANTS).
- 3. CHP (California Highway Patrol) arrests on a San Diego Municipal Court Warrant for (M) 23152(A) PC with NO BAIL.
 - NO. ONLY IF THE ORIGINATING ARRESTING AGENCY WAS SDPD/SDHP. (BAC #7-WARANTS).
- 4. SDPD (San Diego Police Department) arrests on a (M) 594(B)(1) PC.
 - CITY, ANY FIELD ARREST CHARGES BROUGHT IN BY SDPD/SDHP THAT DO NOT MEET THE BOOKING ACCEPTANCE CRITERIA ARE PROCESSED AS CITY INMATES. (BAC #11-FIELD)
- 5. SDPD (San Diego Police Department) arrests on a (M) 11550 HS and (M) 4142 BP.

 CITY, THE 11550 HS CHARGE MEETS THE BOOKING ACCEPTANCE CRITERIA BUT 4140 BP

 DOES NOT. THEREFORE, THIS ARREST WILL BE PROCESSED AS A CITY INMATE.

 ACCORDING TO THE B&R SECTION OF THE DPT MANUAL, ANY B&R CHARGES BROUGHT

 IN WITH ADDITIONAL MISDEMEANOR CHARGES THAT DO NOT MEET THE BOOKING

 ACCEPTANCE CRITERIA MAKES THE ARREST A CITY INMATE.



- 6. SDPD (San Diego Police Department) arrests on a (M) 647(f) PC CHRONIC. CITY, ACCORDING TO THE CITY INMATES SECTION OF THE DPT MANUAL, ANY SDPD/SDHP ARREST OF A 647(F) CHRONIC WILL BE KEPT AS A CITY INMATE.
- 7. SDHP (San Diego Harbor Police Department) arrests on a (M) 148(A) PC, (M) 647(f) PC, (M) 11364 HS and a (M) 417(A)(1) PC. NO, ACCORDING TO THE BOOKING ACCEPTANCE CRITERIA, 417(A)(1) PC IS AN ACCEPTABLE MISDEMEANOR CHARGE THAT GETS THE INMATE THROUGH THE DOOR. THEREFORE, THIS IS NOT A CITY INMATE.
- 8. SDPD (San Diego Police Department) arrests on a San Diego Municipal Court Warrant for (F) 290(G)(2) PC. NO, ACCORDING TO THE WARRANTS SECTION OF THE BOOKING ACCEPTANCE CRITERIA,
 - ALL SEX/NARCOTIC REGISTRANT WARRANTS ARE ACCEPTABLE. (BAC #13-WARRANTS)
- 9. SDPD (San Diego Police Department) arrests on a North County Municipal Commit Warrant for (M) 23152 (A) VC. NO, ALL COMMIT WARRANTS ARE ACCEPTED FROM ANY LAW ENFORCEMENT AGENCY. (BAC #5-WARRANTS)
- 10. SDPD (San Diego Police Department) arrests on a (M) Los Angeles County Municipal Court Warrant for 243 PC DV.
 - NO, ACCORDING TO THE BOOKING ACCEPTANCE CRITERIA, MISDEMEANOR OUT OF COUNTY WARRANTS (INCLUDING DV), ARE UNACCEPTABLE. (BAC # 19-WARRANTS).
- 11. SDHP (San Diego Harbor Police Department) makes a field arrest on an (I) 11357(b) HS. 11357(B) HS IS AN INFRACTION AND IS NO LONGER A BOOKABLE CHARGE. (BAC; FIELD; OTHER; NOTE REMOVED).
