Note: If this is the only charge listed on the J-15, it must be verified with the arresting officer what crime the arrestee conspired to commit. This is necessary to determine what bail amountwill be applied. If a conspiracy charge comes in with a misdemeanor/felony charge, the bail would be the same amount as that charge but WILL NOT be stacked unless directed to do so by the arresting officer on the J-15 (see example).

In addition, Conspiracy to commit a misdemeanor offense is a "wobbler" that can be charged as either a felony or a misdemeanor. Verify with the arresting officer the desired charge level for the Conspiracy – felony or misdemeanor. The court destination for arraignment shall be scheduled accordingly, per 825 PC.
