



ARST – Field Arrest – Serial Inebriate Program (SIP)/Chronic

A Chronic Drunk and/or S.I.P. incarcerated individual is only accepted from agencies with prior approval or documentation on file. At this time, ONLY SDPD, SDHP, ESPD, OPD, CBPD, SOVI Chronic/S.I.P. incarcerated persons remain in custody.

Arrests from **El Cajon Police Department (ECPD)** reflecting “Chronic” or S.I.P. will be accepted but **will not** be kept in custody. The J-14 will be used, and the incarcerated individual will be processed as a book and release per PC 853.6.

Arrests from **Lemon Grove Sheriff’s station** reflecting LG-SIP will be accepted but will not be kept in custody. The J-14 will be used, and the incarcerated individual will be processed as a book and release per PC 853.6.
