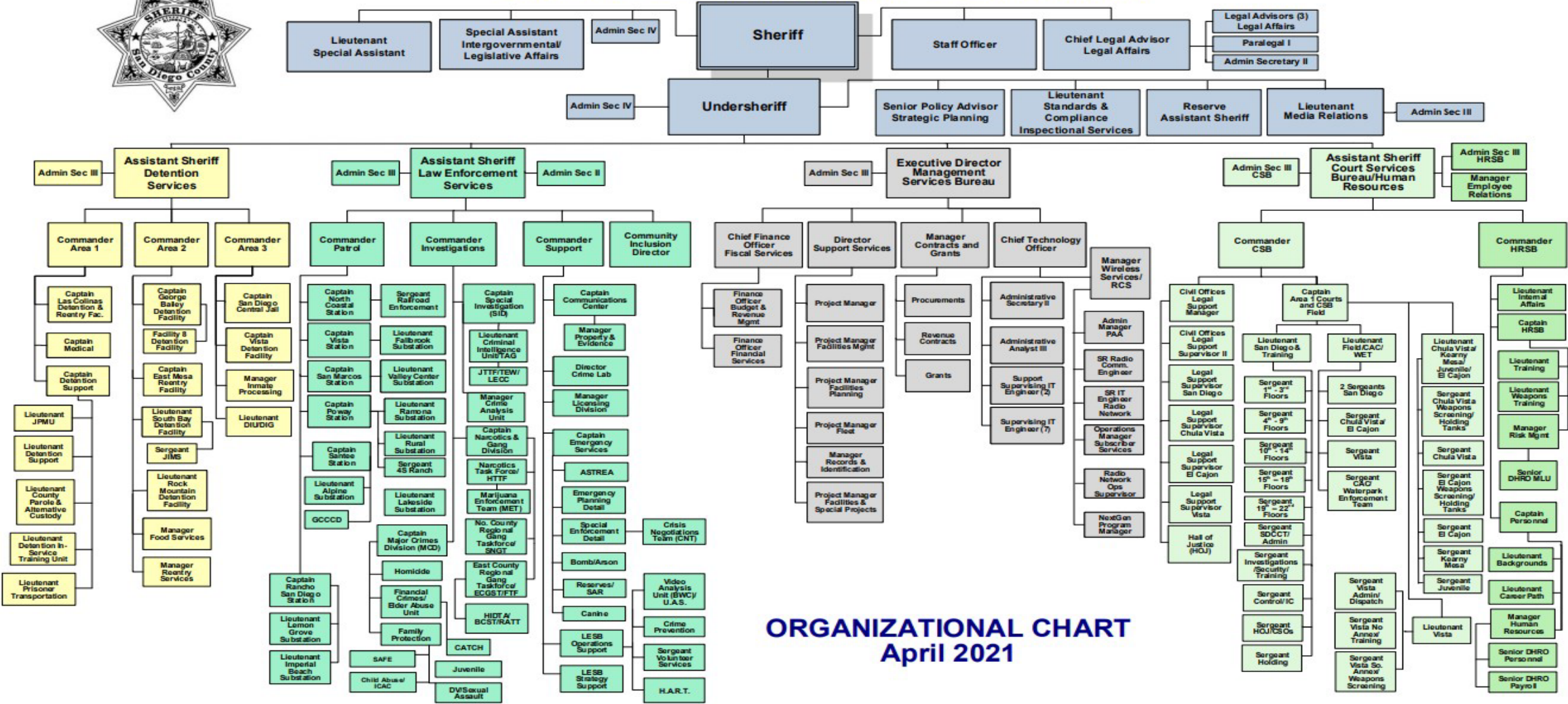

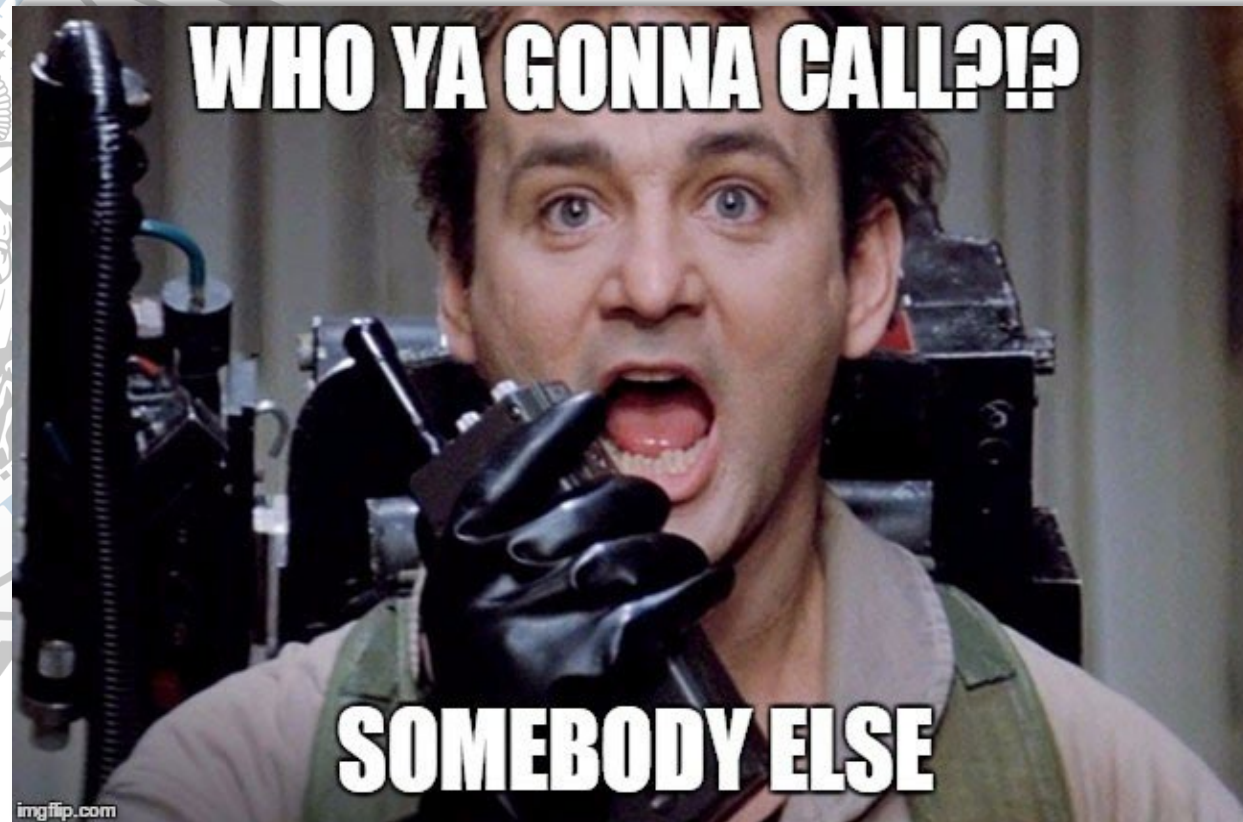

WHO CAN REQUEST SERVICES FROM LEGAL AFFAIRS

- P&P section 1.13:
- In order to promote efficiency and consistency, all requests for legal services, opinions, and inquiries must go through the chain of command, up to the level of Captain, watch commander, or professional staff equivalents. However, notifications mandated by P&P sections 6.123 and 6.124 (summons, complaints, subpoenas) should be forwarded to the Legal Affairs Unit directly.
