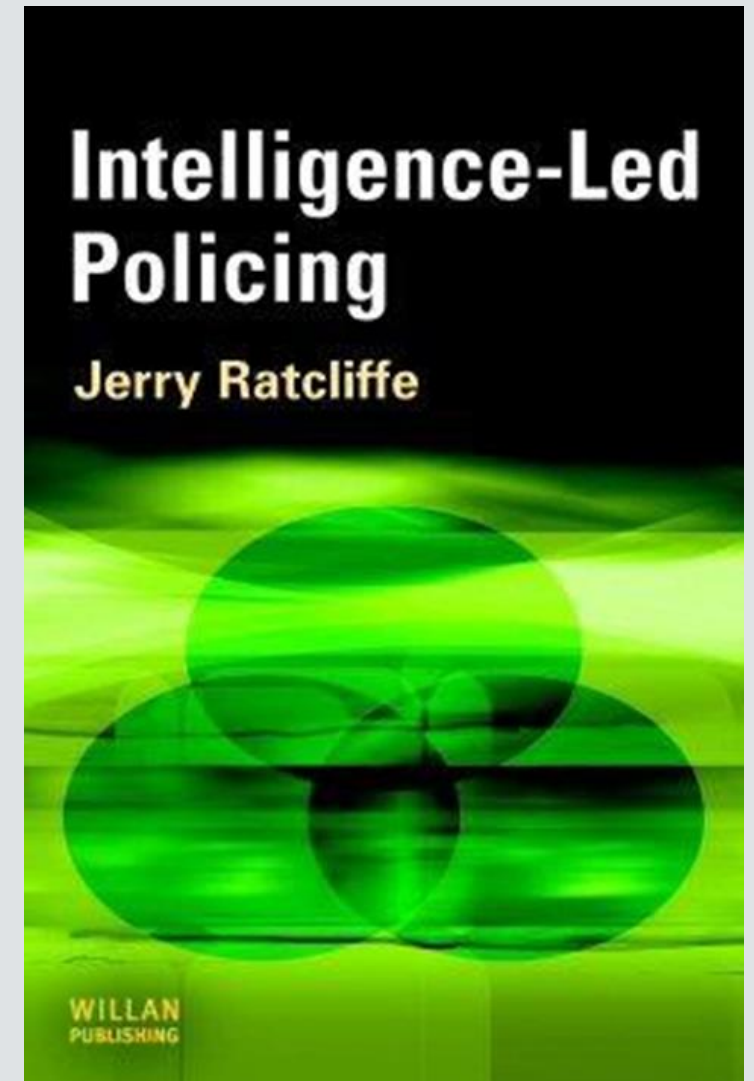

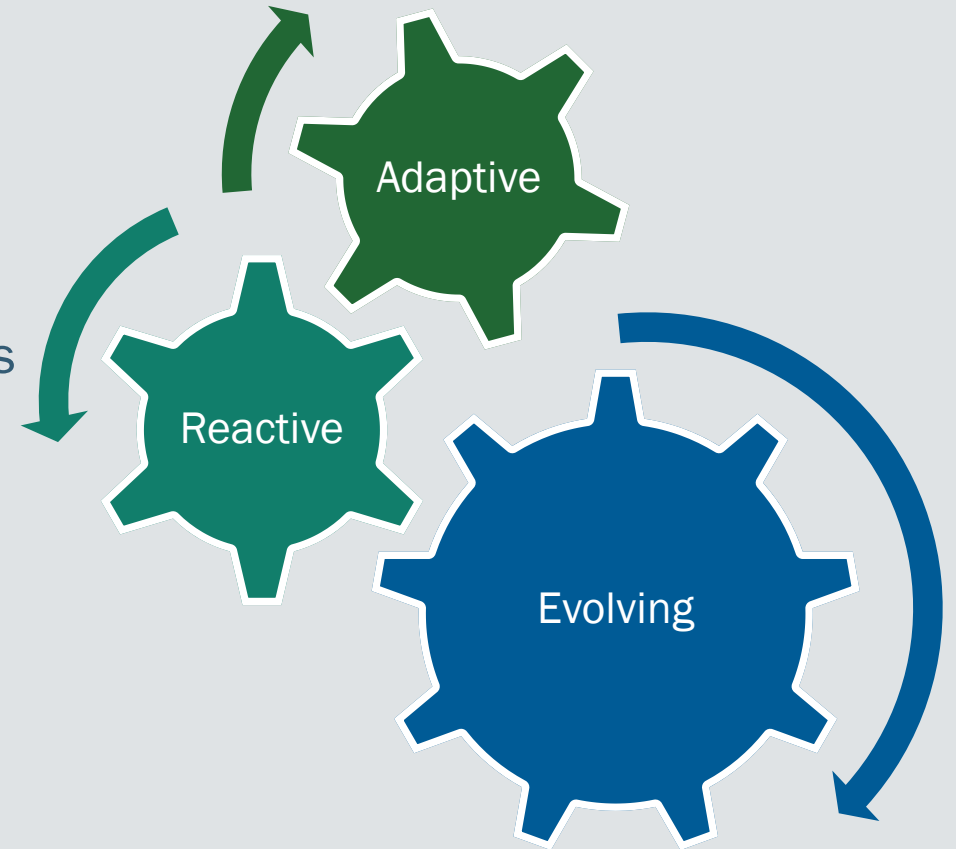

WHY ILP and Analysts?

- San Diego is the 5th most populous county in the US, with a lot of unincorporated areas patrolled by the Sheriff's department.
- There is a need to analyze and evaluate large amounts of data to better understand the specific crime problems in each area.
- ILP provides a mechanism to reassess our strategies, refine our law enforcement operations, and respond to on-going concerns.
- Analysts enhance our capabilities in tedious or meticulous analysis or investigations.

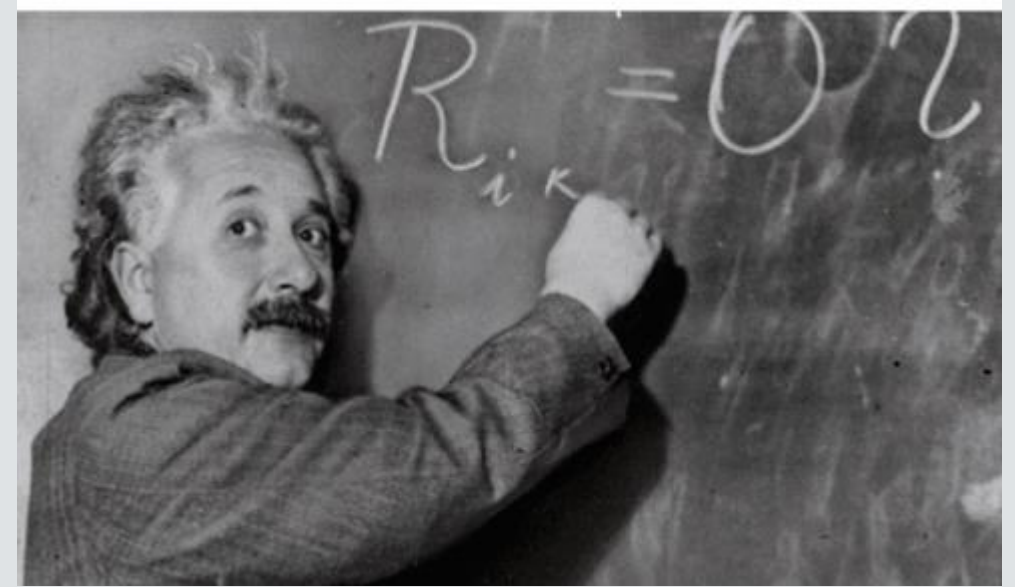


The Analysts Role in ILP

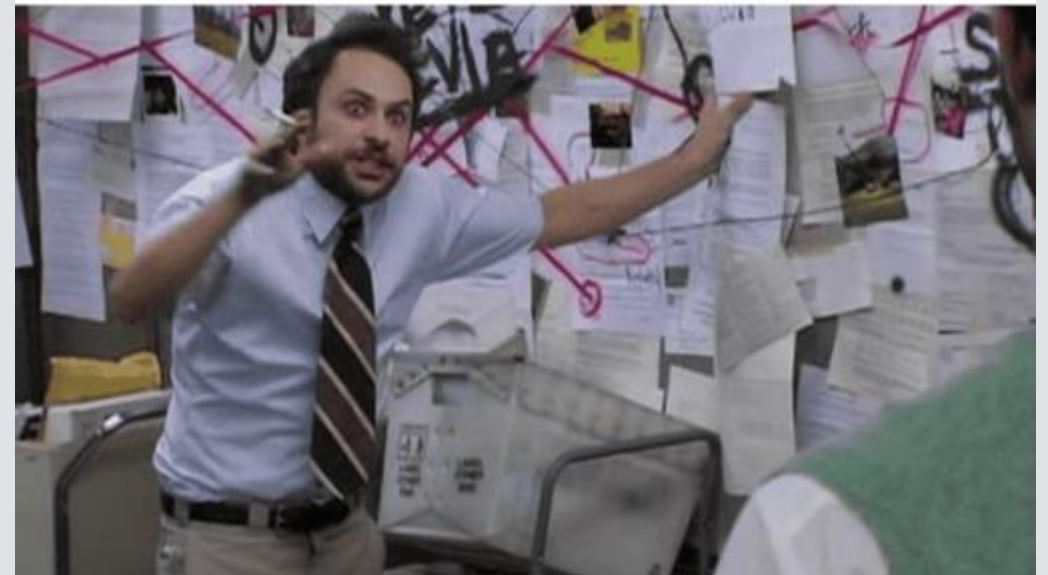
- A resource that elevates the intelligence gathering process.
- Important to remember that data also needs to be analyzed before and after enforcement actions.
- The analyst should take information or data and turn it into intelligence.



How we think we are explaining our theory

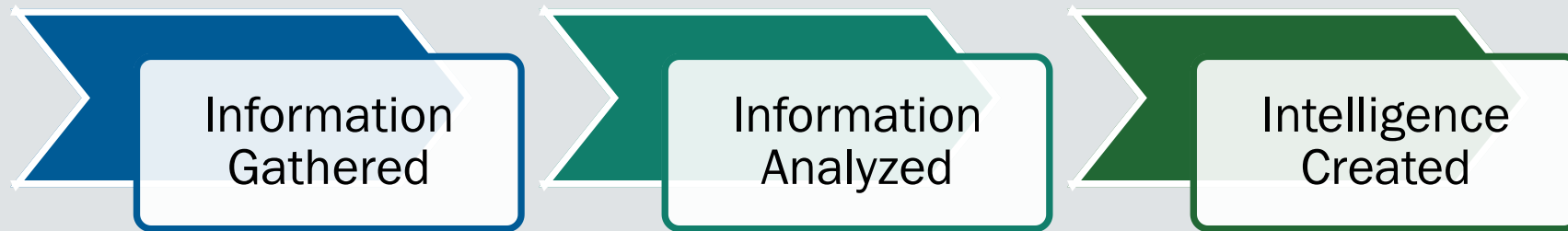


How we actually look explaining our theory

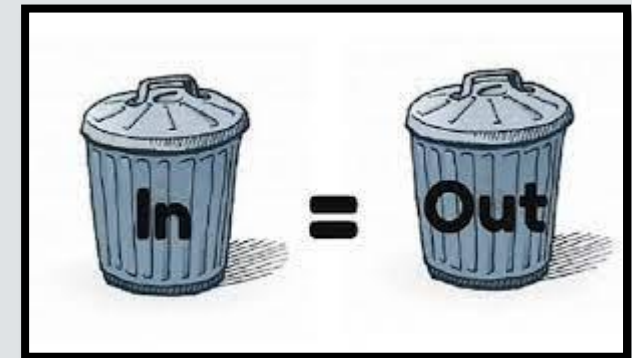


**What is the difference between
Intelligence and Information?**

- Information - reports about a specific event or activity. The "raw data". "Analysts are not reporters"



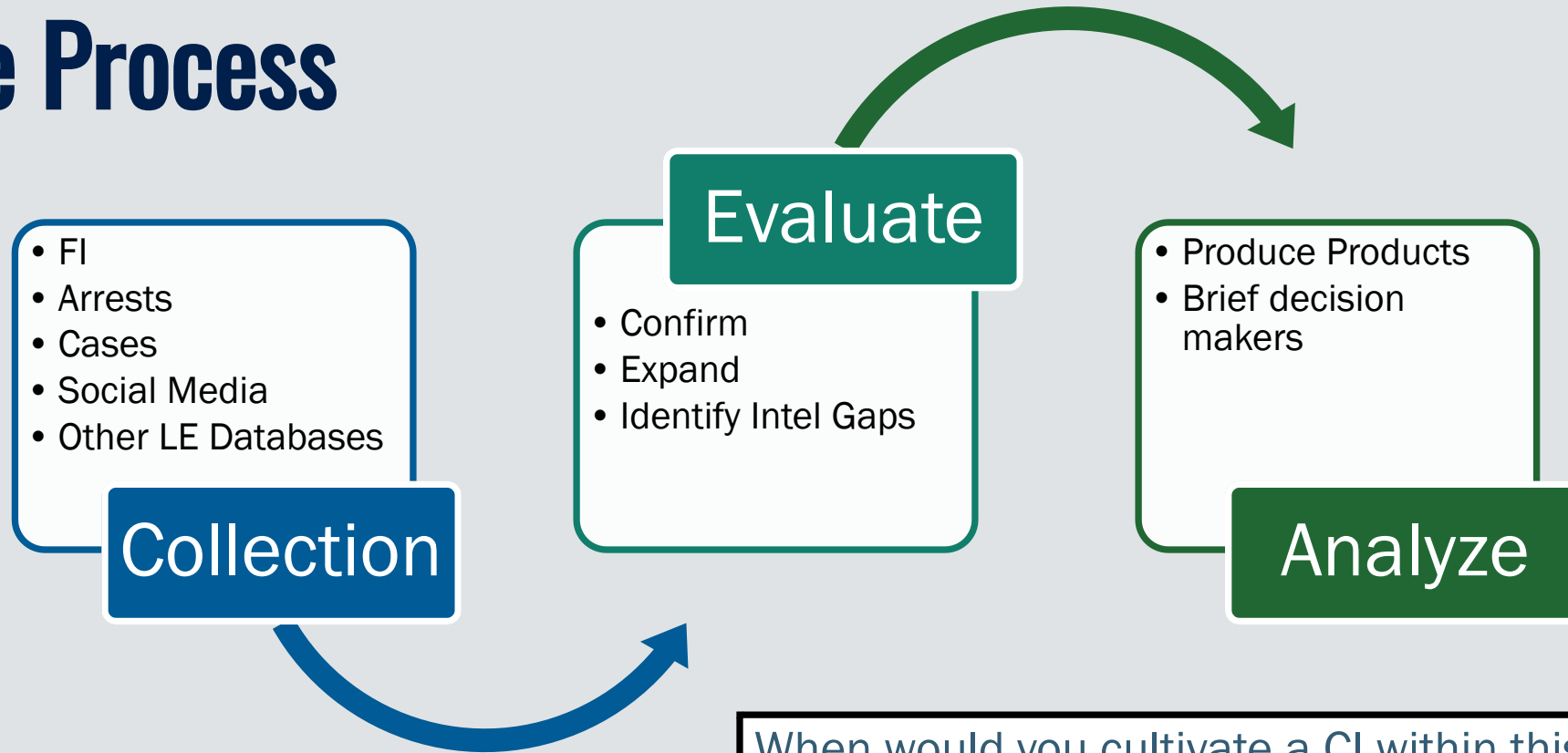
- Intelligence – Evaluated and analyzed information.
 - *Context must be provided*
 - *Corroboration must be supplied*
 - *Value must be added*

The Process



- ILP is about collecting and utilizing information.
 - Evaluating it to process it into intelligence
 - Analyzing that intelligence to produce products that support informed decision- making.

ILP Example

- San Marcos
 - *On March 3, 2016 the San Marcos station pulled four deputies from patrol and reassigned them to a Special Enforcement Team (SET) dedicated to Nordahl Market Place. Nordahl Market Place was identified as a hot spot for not only shoplifting but its drug activity. Crime and intelligence analysts put together an information lead policing (ILP) action plan to mold the SET teams hours which assigned two deputies to Nordahl Market Place during the most criminally active days and times. San Marcos Station also worked with Vista Detention Facility to book prominent misdemeanor offenses from the area for approximately three months.*
 - *Between the SET and patrol there was approximately 178 arrests made at Nordahl Market Place from March to May 2016. As a result of the team, shoplifts in May 2016 dropped 50 percent from the monthly average of 56 to 28.*
