Recommendation for Medal of Valor
Deputies Aaron Tenorio (#3413) and Sean O'Rourke (#1401)

On the evening of April 29, 2021, Deputies O'Rourke and Tenorio responded to a radio call of domestic violence occurring between a husband and wife at a residence on Dain Court in Lemon Grove. Upon arrival, Deputies O'Rourke and Tenorio met with a concerned family member outside the residence. The family member expressed concern that the husband was being violent. Deputies O'Rourke & Tenorio could hear sounds of a struggle followed by a female screaming inside the residence from the second story. At this point, the incident was still rapidly developing and other responding support units were still a considerably distance out, which enhanced the dangerous situation.

Realizing the severity of the situation and aware that someone inside the home was in imminent distress, Deputies O'Rourke & Tenorio breached the locked front door and made entry into the residence to intervene on the domestic violence incident. Deputies O'Rourke & Tenorio quickly moved to the master bedroom on the second story of the residence where they last heard the victim in distress. There was fresh blood on the walls and floor of the master bedroom, and Deputies O'Rourke & Tenorio followed a blood trail to a walk-in closet, where they encountered a female victim who was bleeding profusely from multiple stab wounds. The suspect was on top of the victim and partially concealed under piles of clothing scattered on the floor. Deputies O'Rourke and Tenorio immediately addressed the male suspect and overcame his resistance, taking him into custody after a brief struggle. A large knife covered in the victim's blood was found where the suspect was initially contacted.

Life-saving efforts were made on the victim, but unfortunately her wounds were not survivable, and she died of her injuries sustained by the suspect. During her final moments, the tending deputies remained compassionate and reassured the victim, relieving her of significant emotional trauma. The suspect was arrested on scene for murder.

Deputies O'Rourke and Tenorio are to be commended for their unhesitating response to a volatile, dangerous situation and their fast intervention in their attempt to save lives. During their actions to breach the front door and make entry into the residence to locate the victim, they put their own personal safety in peril to try to save the life of an innocent victim. Using sound tactics, they were able to avoid becoming subject to an ambush and successfully resolved the incident. Their actions on scene resulted in the immediate arrest of an extremely dangerous individual and provided closure to the family of the victim in this tragic incident.

I am honored to recommend Deputies O'Rourke and Tenorio for a Sheriff's Medal of Valor for their actions during this incident.

On June 11, 2022, Deputies Nicholas Kafkas, Aaron Tenorio, and Corey Heiserman responded to a domestic violence incident at a residence in the city of Lemon Grove. Deputies contacted the victim outside. The victim had visible facial injuries that were inflicted from his girlfriend, who was still inside the residence. Deputy Kafkas approached the front door of the residence and began to call out for the suspect to come out. Getting no response, Deputy Kafkas took a safe position outside the door and opened it slightly to look inside. The suspect came out of a hallway, her arms covered in blood from self-inflicted knife wounds, and charged at Deputy Kafkas. To avoid a violent assault, Deputy Kafkas remained outside and closed the door on the suspect before she was able to reach him.

Deputy Kafkas developed a plan of action with his partners. Concerned that the suspect was seriously injured based on the amount of blood observed, Deputies Kafkas, Heiserman, and Tenorio felt the exigent need to make entry to render aid to the suspect as well as take her into custody for felony domestic violence.

The deputies made entry into the apartment, but did not immediately find the suspect, who at this point they knew was likely armed with a knife and suicidal. After making entry, deputies observed large pools of blood on the floor. While clearing the living room, the suspect emerged from a hallway and yelled at the deputies, challenging them. The suspect did not appear to be armed, so Deputy Kafkas moved to take her into custody. The suspect was non-compliant and due to the large pools of blood on the floor, Deputy Kafkas and the suspect fell down. Deputy Kafkas observed several very deep lacerations that were bleeding profusely on the suspect's both arms. While on the floor, the suspect continued to struggle with Deputy Kafkas. Unknown if the suspect had a knife hidden on her person, Deputy Heiserman deployed his Conducted Energy Device (CED) to immobilize her so she could be handcuffed. Deputy Kafkas and Deputy Heiserman were able to handcuff the suspect and restrain her. Deputy Tenorio continued clearing the residence to ensure there were no additional victims inside.

Immediately after securing the suspect, Deputy Kafkas used towels to put pressure on the most severe lacerations on her right arm to slow the bleeding. Deputy Heiserman checked for additional injuries and found several very deep lacerations on her left arm as well. Recognizing the suspect was losing a large amount of blood and was in danger of bleeding to death, Deputies Heiserman and Kafkas applied a tourniquet to her left arm. The tourniquet application was successful in controlling the bleeding.

The gravely injured woman was transported to Scripps Mercy Hospital via ambulance and underwent emergency trauma surgery on her self-inflicted lacerations. Emergency Department Dr. David Bruner from Scripps later stated that if the deputies had not taken such decisive action when they did, the woman would have died of blood loss within a matter of minutes.

Deputies Kafkas, Tenorio, and Heiserman acted quickly once they knew the suspect was bleeding profusely. They knowingly placed themselves in danger by entering the residence despite the risk of the suspect possessing a weapon and assaulting them so they could have the opportunity to provide immediate medical attention to her and save her life.

It is my privilege to recommend Deputy Nicholas Kafkas, Deputy Corey Heiserman, and Deputy Aaron Tenorio for the Sheriff's Medal for Lifesaving.

BRIEF STATEMENT OF EXEMPLARY PERFORMANCE:

On May 17, 2015, RSD Deputies responded to a call of a mentally ill individual who had violently assaulted his mother and brother at their residence on the 1900-block of Hidden Crest in unincorporated El Cajon. Deputies arrived and found two victims suffering from life-threatening injuries from the severe assault by the suspect. One of the victims succumbed to her injuries and died. The suspect had fled the scene in a vehicle just moments before deputies arrived and his vehicle was located, unoccupied, on a narrow side street within a couple miles of the crime scene. A description of the suspect was broadcast and deputies began to search the area for the outstanding suspect. ASTREA 3, piloted by Deputy Scott Bligh with Deputy John West as the Tactical Flight Officer, had been monitoring the call and responded to assist in the search. Deputy West analyzed and evaluated the terrain where the suspect's abandoned vehicle was located. Based on his analysis of the geography, Deputy West determined that the most likely route the fleeing suspect would have taken was towards a densely-populated apartment complex within a mile of the vehicle. ASTREA took the initiative to focus their search efforts in that area. While searching for the suspect, ASTREA announced via PA the suspect description and requested any citizens in the area to call 9-1-1 if they saw the suspect. Within minutes, a citizen called 9-1-1 to report they observed the individual being described by ASTREA running through the apartment complex. This information was relayed and ASTREA, along with deputies on the ground, converged on the area the suspect was last seen. The suspect was quickly located and taken into custody. Thanks to the initiative and quick thinking of Deputies West and Bligh that day, a dangerous mentally unstable murder suspect was apprehended and is no longer a threat to society. It is my pleasure to recommend Deputies John West and Scott Bligh for a Report of Exemplary Performance.

It is requested that a copy of this report be made a permanent record in the employee's departmental personnel file.
