RIPA (Racial Profiling and Identification) Training Update Bulletin

Reminder: The deputy that makes the stop is mandated to fill out the RIPA stop themselves. A partner cannot do this on your behalf, otherwise the partner deputy's information is recorded in the application.

The RIPA application has been updated to address a new data restriction implemented by CA DOJ. If you conduct a stop because of a "Consensual Encounter resulting in a search" you must also indicate what type of search it was, person and/or property. The subsequent page with "Actions Taken During Stop" will display your selection and expand the "Basis for Search" section.

Start of Beat Collection on October 1, 2018

Starting on October 1, 2018, we will require the collection of BEAT information in the RIPA App. There will be a slight change in the way the City is selected as well. Please follow these steps to make the new functionality available on your device.

Please refresh the cache. If you have a stop form in progress, either cancel it or finish, then click or tap the "Refresh Cache" button on the home screen.

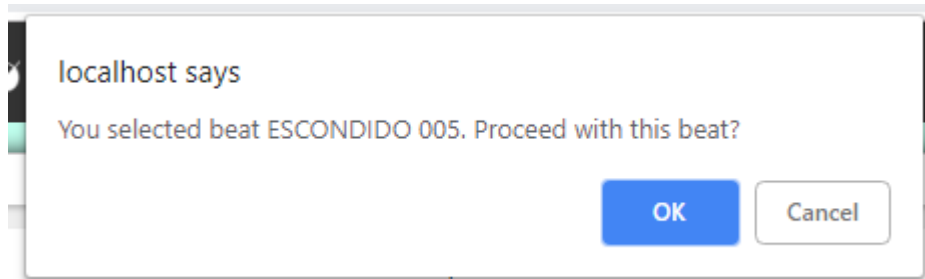
