THE LAW

Paragraph 22511.8, California vehicle code recognizes 3 elements that must occur to have a legal Disabled Person parking stall.

- 1. A posted blue and white disabled person sign visible at or adjacent to each parking stall.
- 2. By outlining or painting the stall or space in blue.
- 3. And outlining on the ground in the stall or space a blue square and outlining in white or suitable contrasting color a profile view depicting a wheelchair with occupant.











Disabled Person Parking Placards

- Permanent Placard Temporary Placard
- Permanent placards are subject to renewal on June 30 of every oddnumbered year.
- Temporary placards are issued for a period of not more than six months.














HOW TO NOTIFY DISPATCH WHEN CHECKING ILLEGAL DISABLED SPACE PARKER

To Check Parkers in Shopping Center When Citation Seems Likely

- UNIT: (City + Area Designator) Victor 71
- DISPATCH: Go Ahead Victor 71
- UNIT: Checking Parker at (Numeric Address) in front of (Store).... on California 4PST179 (Option: Clear for a plate? Then give license number after acknowledgement)
- DISPATCH: 10-4, Station M......Your plate is 11-29 etc.

To Clear Call on Parkers If you Issue a Citation

UNIT: (City + Area Designator) Victor 71, 10-8

To Clear Call on Parkers - No Citation

- UNIT: (City + Area Designator) Victor 71, 10-8 **OK**
- DISPATCH: 10-4, Station M

Issuing A Citation

(Violation of Section 22507.8)

- Write legibly printing preferred
- No cross-outs
- Mistake. Void cite and start over
- Fill in all applicable blanks
- Indicate photos taken or submitted
- Goldenrod (yellow) copy with envelope on windshield, pink and white to station

HOW AND WHEN TO VOID A DISABLED SPACE CITATION

Voiding a Citation

- All 3 copies back together and mark with large "X" or write "VOID"
- Write brief reason for voiding
- Citations are voided at the location if person returns and has a valid placard.
- Other on-location situations may warrant a void
- Only the person issuing the citation may void it.
- Superiors e.g. Sgt., Lt, etc. may, but usually do not, void others cites.

HOW TO FILL OUT A CITATION AMENDMENT FORM

Citation Amendment Form

- May need to amend citation after leaving the scene and/or returning to station
- Usually used for simple errors e.g. wrong date, day of week, reversed plate numbers, etc.
- Is a formal attestation of a simple error correction that does not affect the validity of the citation
